ELIGIBILITY FOR EVENT:

- Eligibility is "open to all". Senior Partnerships: KC Grades 1,2,3, 4, 5, 6 or 7; Agility 4 All Beginners, Novice, Senior or Champion status on the closing date
- Junior Partnerships – Handlers must be born on or after 1st May 2007.

Handler: To be born in Scotland, have parentage (mother, father or grandparent) born in Scotland, or be a permanent resident in Scotland on the day of the event. Proof may be requested at the selection day.

It is preferred that the handler/dog partnerships competing at the selection day are a regular partnership during current/preceding agility season. Note handlers do not need to be the owner of the dog but must have the owners' permission to take part in the selection day.

Prepare both the handler and dog for a potential podium place.

Promote the sport of Agility in Scotland

Encourage team members to learn from their experience as part of the team and to promote Agility Team Scotland throughout the Scottish Agility community.

ABOUT THE SELECTION DAY

The Selection Day Venue

This is an active equestrian facility and as such please keep dogs under control at all times. Please respect horse owners. Always pick up after your dog and please take your waste away with you.

The venue has a large indoor arena with a sand surface similar to that of the WAO event venue. Ample parking is provided and a limited area to exercise dogs. There is a small café on site.

There is no camping available at the venue

The Selection Process

For WAO 2026, Agility Team Scotland will consist of a minimum of 4 dogs chosen from each height category, i.e. 20. For the senior and 5 for the junior category.

The selection of the team will be the responsibility of team management. There will be three automatic win on spots for each height category available for award following the selection day. It is endeavored these places will be announced on the day, subject to results analysis. A further opportunity is available to gain a place on the team, by entering and achieving the super win on spot at the CSJ event, held 19th to 22nd June 2025. In the event a super win on spot is not awarded at the CSJ event, it is aimed that any further team positions will be notified within 2 weeks of the selection day.

There may be an initial deposit to secure a place on the team.

In the event of force majeure forces cancellation of the selection event, and it cannot be rescheduled, selection will be at the discretion of the team management.

The Selection Days

The day will consist of the following agility challenges:

13th June 2025

- Agility 1
- Jumping 1
- Agility 2
- Jumping 2

14th June 2025

- Gamblers
- Snookers

- Speed Stakes

This may be modified prior to the selection days dependent upon how many entries are received. Any changes will be published to allow partnerships to prepare accordingly.

Equipment used on the days will be aluminum & rubber contacts and jumps which reflect WAO rules and regulations.

Running orders will be published prior to the event. Running will be in strict order.

Dogs in heat can try out on the day and should be run in order. Notification of any dogs in heat should be made known to the team management at the start of the selection day. When running a dog in heat, matting should be used at the start position.

Only 1 ring will be running. Course walking will be in between each round. Course walking will be at the first height to be run in the ring. 8 minutes will be allocated for each course walk. Depending upon entries, course walking may be split into height categories. There will be no course walking between heights.

The Selection Day Criteria for Senior Partnerships

Each partnership will earn a score for each round. This will equate to their placing in that round e.g. 1st place will score 1, 2nd place will score 2 etc. A total score can be defined as the cumulative placings in different rounds on the selection day. To exemplify, a partnership with the following placings in the seven rounds will have a cumulative score of **35**:

The criteria for the win on spots on the team will be as follows:

Following the selection day, there will be 3 win on spots awarded. For clarity Win on Spots are guaranteed to be selected to run that event at the championships.

The first will be the partnership with the lowest total score for Agility 1, Jumping 1, Agility 2, Jumping 2 & Speed stakes rounds and they will be awarded the Pentathlon win on spot. In the event of a tie after 5 rounds for all placings, final rankings will be determined by the result in the Speed stakes round.

The second win on spot will be awarded for the Biathlon. This will be awarded to the partnership with lowest total score in any combination of Agility & Jumping rounds. In the event there is a tie for 1st place then the partnership with the lowest total score from Agility 1 & Agility 2 rounds will be selected. An example of how this will work is as follows:

In the above example, Partnership 1 & 2 both have the same lowest score, in Agility 1 & Jumping 1 and Agility 2 & Jumping 1 respectively. As Partnership 2 has a lower score in Agility 1 & Agility 2, the win on spot is awarded to Partnership 2.

The third win on spot will be awarded for the Games. This will be awarded to the partnership with the lowest total score from the Gamblers and Snookers rounds. In the event of a tie after both rounds, for all placings final rankings will be determined by the result in the Gamblers round

Agility Team Scotland wishes to ensure a breadth of partnerships are selected. In the event a partnership gains all 3 win on spots, the pentathlon rankings will determine the additional spot(s). The same determination will be applied in the event a partnership does not gain the win on spot at the CSJ event or opts to take the Junior Win on Spot.

Team management reserves the right to award a 5th spot for any height. This will be restricted to a partnership who, in the previous 12months, has gained a podium position at Crufts, KC agility stakes or a prestigious international event or have been awarded a CC and who participated in but did not have a successful try outs.

Team management may also extend the invitation to a partnership to participate in the team event. This partnership will not be eligible to run in any individual events, although will play a fully participative role in the team event.

The team management may decide to offer a reserve place(s) to any partnership. Only partnerships meeting the requirements detailed in the selection process above will be considered.

Selection of the Junior Partnerships

Scoring for the junior partnerships will be the same as the senior. This will be awarded to the partnership with the highest ranking in the pentathlon competition.

Scoring for Ranking on the selection day

Scoring will be based upon a combination of faults and time. Any faults incurred will be added to the time in seconds i.e. 5 faults will result in 5 seconds being added

The following faults will be employed during the selection day

- Knocked pole, refusal, missed contact, incorrect weave = 5 faults
- Elimination = 15 faults (note: there is no need to correct an elimination but should continue course from where elimination occurred)
- Failure to make a concerted effort to complete the course = 100 faults (e.g. elimination at jump 5 then heading straight to finish therefore avoiding potential further faults)

The awarding of faults is solely at the discretion of the judge. These faults are different from the standard WAO scoring (which can be found <http://www.worldagilityopen.com/WAORules&Regulations.pdf>) but designed such as to encourage partnerships to attack the course. Even after elimination, faults will still be incurred so partnerships are encouraged to keep working.

A placing will be given to all partnerships. In the event of a tie of faults and time in a particular round then the partnerships will be given the same placing. This will be the higher of the places. The table below exemplifies.

Partnerships that have automatically qualified for the 2026 WAO through achieving a podium position at the 2025 event must enter the selection day if wanting to be considered as part of ATS for other events that they did not win a podium spot for.

Allocation of Runs at the event

In addition to any podium positions from previous years competition, each country is restricted to 3 dogs per height per event. Those partnerships who gained a win on spot for a particular event are guaranteed that event. The same is true for the super win on spot from CSJ. Further allocations will be determined by results from the selection day.

Some basic rules *(these are taken from WAO rules <http://www.worldagilityopen.com/WAORules&Regulations.pdf>)*

Collars & Leads

Dogs must not wear any type of slip or half-slip lead, half collar, muzzle, harness or collar while competing. Stop pad protectors may be worn by a dog if approved by the team management. Leads will be placed at the exit of the ring in a container. Only the handler may retrieve their lead from this container. Electric or choke chain collars may not be used anywhere at the selection event.

Timing & Equipment Failure Procedure

If during a competitors run, the timing fails, the competitor will rerun again however all faults from the first run will count. In the event of a re-run, the judge must deem that the handler has made a true and sportsman like effort to complete the course correctly or additional faults can be added.

Jump Height/Dog Height

There are five qualifying height divisions, so that dogs compete against dogs of a similar height. Dogs may compete in a division larger than the actual dog's height, but cannot compete in a lower division. Example: A dog which measures 450mm may enter & compete in the 600 division, but cannot compete in the 400 division. All dogs wanting to compete below the 600 class must obtain a record of measurement or already have an official WAO measurement. It is aimed to have measuring available at the selection day.

If agreed with Agility Team Scotland Management prior to the selection event, a handler may choose to run in a height division above at the selection event and still be considered for the height their dog measures into. For example, a dog may measure into the 250mm height division, however a handler wishes to run at 300mm at the selection to minimize jump height changes in the middle of the season. In doing so, handlers agree, no compensation will be given for impact to recorded times. No dogs will be allowed to run at a height lower than they measure into at the selection event.

Initial information for WAO event in 2026

If fortunate enough to be selected as part of Agility Team Scotland the following points should be noted:

Costs

Costs to the team members will be kept to a minimum where possible. Every effort will be made to attract support and sponsorship for ATS by the team management. Team members are encouraged to fund raise personally to support their attendance at the event. There may be some restrictions on the sources of personal fund raising and subsequent publicity. These will be further detailed post the selection event.

Once known and as soon as possible, full costing for ATS participating at the 2026 WAO event will be given to team members.

There will be at least 1 fund raising activity to be held by the team to assist with costs for attending the event. Participation in the preparation and running of that activity is expected of team members and failure to do so will jeopardize their place on the team.

Team Training Sessions and Partnership Preparedness.

There will be 3 team sessions. These will be held on 22nd Nov 2025, 24th Jan 2026 & 21st Mar 2026.

Venue for these TBC.

Attendance to these team sessions is compulsory unless exceptional circumstances as deemed by the team management. For those new team members who have not participated for Agility Team Scotland prior, additional dates will be arranged for either in person or virtual preparation sessions.

These team sessions are held to aid communication in readiness for the event and will cover, amongst other points, personal preparation for partnerships, team event rules and regulations and games, which is unfamiliar to many handlers in Scotland.

It is expected that partnerships will prepare a personal preparation plan leading up to their participation at the event. They should be willing to share and discuss this plan with team management.

Team management may invite suitably qualified veterinary/human physiotherapist/fitness consultation to one of the team sessions or request partnerships to undergo an assessment outside of official training sessions. This is to aid with identifying any fitness issues and assist partnerships in their preparations plans for what can be a physically demanding event for both dogs and handlers.

Sponsorship Clause

As being part of Agility Team Scotland, handlers will be expected to sign a sponsorship clause. This is to ensure your commitment to thank official team sponsors in any social media posts, blogs or podcasts associated with Agility Team Scotland. You would also be committing to solely thank official team sponsors. No other businesses, including those of personal sponsorship or personal professional promotion, shall be included in social media posts, blogs or podcasts associated with Agility Team Scotland.

Travel and accommodation for the event

It is expected partnerships organize their own travel arrangements for the WAO event. Team members are encouraged to share transport where possible.

Provisional accommodation booking for the event will be made by the team management. Whilst there is a benefit for all members of the team to be at the same accommodation, team members can find alternate accommodation should they choose.

All travel and accommodation costs will be the responsibility of team members. ATS will not fund travel and accommodation either in part or full.

Team outfit

A team outfit including tops, jackets and mid layer will be selected by the team management. Team members will be able to size and select required garments at one of the team sessions. Team members are expected to fund the cost of their team outfit. As a minimum, team members are expected to obtain 4 tops and a mid-layer for the event. Additional items are optional.
